Score the Shore Has Begun!

Mike Gallagher has organized a team of eight GLQO members to score the 68 parcels (each 1000 ft) of Gull Lake shoreline starting June 15. They expect to be able to do 2-4 parcels each time they are out so if all goes well, they should be done by the end of July! Keep an eye out for Mike's pontoon boat – they will have a Gull Lake Quality Organization banner displayed. Give a wave when you see them! Another team will be surveying Little Long Lake later in the summer.

So what's involved? The team will take three passes by each parcel and measure specific characteristics on each pass. Data they collect includes the number of buildings and docks/lifts, characteristics of the shoreline (the "riparian zone"), vegetation and other features of the waters off the shoreline (the "littoral zone"), and shoreline erosion control practices. Depending on the complexity of the shoreline and clarity of the water, this can take 20-40 minutes per parcel. So, don't be concerned if you see a boat floating along your shoreline and people with clipboards on board!

Data from the three passes will be compiled to give a score for each parcel and from this a total score developed for the lake. Because the same parcels that were surveyed in 2016 are being rescored in 2024 (we use GPS to locate the parcels) scores can be compared to see which areas have improved. We expect given the growing interest in making shorelines more natural that we will see an improvement in the score for Gull Lake!

The overall score for Gull and Little Long Lakes will be reported to the Michigan Cooperative Lakes Management Program (MiCorps). You can find more information about the Score the Shore and other programs supported by MiCorps from their website (www.MiCorps.net).

Gull Lake Fishing – Is It Good?

How is the fishing in Gull Lake? It depends on who you ask and when. Some say that fishing is great now because the ice anglers did not take them all. Others say that it is down because the DNR stopped stocking. We all know that the fish bite is variable throughout the day, week, and season and that perceptions of the fishery can change over-time.

So how do we know how good the fishery is?

The best way to evaluate a fishery is to have the DNR conduct a survey using a variety of nets and other sampling gear to get an understanding of fish diversity and population density. But this type of survey is labor and time intensive. Gull Lake has not been surveyed since 2002. In 2002, ang over 30 species of fish were observed with only the trout species requiring regular stocking. The rest of the fish species reproduce naturally. Fish need the right habitat for reproduction and survival and Gull Lake provides excellent habitat with shallow vegetation areas, rock and gravel shorelines, and deep drop offs. When will there be another full fish survey in Gull Lake? Probably not soon, as low staffing and budget levels have popular lakes on an every 30-year survey rotation and the average lake on a 90-year rotation.

An alternative way to track fisheries is through voluntary data. A 2018 voluntary winter creel survey showed that most anglers targeted Rainbow Smelt, Bluegill, Black Crappie, Yellow Perch, and Northern Pike. Anglers reported 1,414 fish caught with 83% of those being Rainbow Smelt. Some anglers also collected length and aging structures throughout the year from Northern Pike in 2018 under the direction of the DNR. These data indicated an abundance of younger (less than 4 years old) Northern Pike, and a lack of older Northern Pike. This could be an indication of high harvest on the larger pike. After an extensive review of the data, the DNR is proposing a protective slot limit between 24 and 34 inches for Northern Pike, which is currently under public review.

Another source of voluntary information is the DNR's Master Angler Award Program that recognizes record sized fish caught in Michigan. Gull Lake has numerous Master Angler records. These include 34 awards for large Black Crappie (some over 16 inches in length!). Other notable Master Angler awards include 18 Rock Bass, 5 Yellow Perch (one over 15 inches!), 3 Northern Pike, and a 32-inch Brown Trout.

Based on angler reports, there are still a few Brown Trout and Lake Trout in Gull Lake. Stocking of Rainbow Trout and Brown Trout was discontinued due to poor survival. Prairieville Creek, however, is a source of naturally reproduced Brown Trout. Occasionally, adult broodstock Lake Trout are also stocked into Gull Lake when they are available.

Although the fish bite on Gull Lake may be slow at times, all available information suggests that the fishery continues to be in very good shape.

This Year's GLQO Annual Meeting: An informative evening!

Over 60 members of the GLQO gathered at the Kellogg Manor House on June 11 for the Annual Meeting. Information shared at the meeting included updates on the GLQO finances and membership, ongoing efforts to survey and manage aquatic invasive species, and new activities sponsored by the Outreach and Communications Team. The success of these outreach activities is reflected in the growing number of new and Lifetime memberships in the GLQO!

The membership was asked to confirm the recommendations of the Nominating Committee to add Kathy Gallagher and Joe Lukeman to the Board. The motion to accept was made by Sera Gesmundo and seconded by Tom Belco; the motion passed unanimously. Both Joe and Kathy will begin 3-year terms on the Board starting in September 2024. The early retirement of Mike Gallagher from the Board was also announced; Gary Mittelbach will fulfill his term. Also, Vicki Gesmundo will be retiring from the Board in August 2024; Susan Harrison has agreed to fulfill her term starting in September. The officers for the coming year were also announced: Kay Gross, President, Ellen Keenan (Vice President), Don Paulson (Treasurer) and Trudy Leudecking (Secretary). These officers will be confirmed at the September board meeting.

The contributions of several members who volunteer to support the GLQO was also noted. Special thanks and appreciation to Eric Reid for coordinating the Newsletter, website and Facebook page for GLQO. He plays a critical role in keeping the membership (and others) informed about the work GLQO is doing. Also, Kathy Gallagher for her assistance with membership monitoring and Mike Gallagher and John Etzcorn for continuing efforts to monitor water quality in Gull Lake and Little Long Lake, respectively. Mike has also put together a team of 8 volunteers to assist with the *Score the Shore* monitoring in Gull Lake. The team have begun their surveys on Gull Lake and as of this meeting had completed 7 (of the 68 sections) to be scored. (More information about *Score the Shore* is described on Page 2).

A highlight of the evening was a presentation by Erica Bays, from Michigan Dept. of Environment, Great Lakes and Energy on the work they are doing to monitor PFAS levels in the ground water around Gull Lake. She provided a number of very detailed maps and charts that demonstrated where PFAS levels are above detection limits in and around the area to the south and east of Gull Lake; most of this associated with contamination from the former plastics plating plant in Richland. The source of PFAS contamination in the Idlewild neighborhood is not clear but given the data from the test wells is not likely to be from the old Production Plated Plastics plant. Confusion regarding the high PFAS levels that have been detected in smelt, in Gull Lake and other lakes, was discussed. This may be the result of an interaction between the process for testing and bile in smelt; EGLE is developing new protocols for this test that will be implemented in 2024 or 2025 and hopefully will resolve this anomaly. Boating Safely - It's Every Body's Business!

The clean water, size and depth of Gull Lake make it an ideal for a variety of aquatic recreational activities, including sailing, skiing, motoring, canoeing, kayaking and fishing. And, in the summer, the lake can be a busy place!

The State of Michigan has laws to ensure safe boating and to protect people and property on or around a lake. It is the responsibility of the boat operator to know these laws, as they can change. While there are specifics about boating speed, direction, distance from shore that a boat should be operated, common sense and respect for others using the lake is a good guide! A summary of these laws and other useful information about boating safety can be found on the GLQO website under the Boating Safety tab.

Both the Kalamazoo County Sheriff Department and Ross Township Police Department patrol Gull Lake to ensure that it is safe for all users. And while these units can (and do) issue tickets to violators, most of their interactions with boaters result in warnings. Of the over 1100 'contacts' between Sheriff's Patrol and boaters over the past two years (2021, 2022), only 11 (< 1%) resulted in citations. And they have also assisted boaters who are stranded! While lake patrols are primarily on weekends and holidays, they are available to assist boaters and/or respond to concerns about safe boating at any time: Dial 911 if you have a concern.

In addition, officers from the Michigan Department of Natural Resources patrol Gull Lake to ensure that boaters are following the state laws for operating a boat (registration, training etc.) and the location of buoys near shore. However, most of their attention is focused on fishing regulations (licenses, limits, etc.).

It is important to note that Kalamazoo County, Ross and Richland Townships have anti-noise ordinances that apply to the operation of boats. Both Ross Township and Kalamazoo County have successfully prosecuted boaters for noise violations in the past two years. Ross Township recently updated (effective 16 May 2024) its anti-noise ordinance to make it clearer what constitutes unreasonable noise; you can read the details on their website (search Anti-Noise Ordinance). The new ordinance also outlines a permitting process that can be used to apply for an exemption to this ordinance for specials events.

So, enjoy the summer... the water is great out there!
